3	Ordinance adopting regulation of vending within the jurisdiction of the Port of San
4	Francisco, requiring permits, and authorizing permit fee and enforcement actions in the
5	Port Code; requiring the Port and the Department of Public Health to report to the
6	Board of Supervisors about regulatory implementation and health and safety
7	enforcement; amending provisions of the Port Code and repealing peddler regulations
8	in the Police Code to comply with state law regarding sidewalk vending; amending
9	provisions of the Administrative, Business and Tax Regulations, Health, and
10	Transportation Codes to conform with state law and new Port Code regulations
11	regarding vending; and adopting findings under the California Environmental Quality
12	Act.

18	Be it ordained by the People of the City and County of San Francisco
19	Section 1. Environmental Findings.
20	The Planning Department has determined that the actions contemplated in this
21	ordinance comply with the California Environmental Quality Act (California Public Resources
22	Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
23	Supervisors in File No. 210566 and is incorporated herein by reference.

Section 2. General Findings.

(a) The Port of San Francisco ("Port") manages the waterfront as the gateway to a
world-class city, and advances environmentally and financially sustainable maritime,
recreational, and economic opportunities to serve the City and County of San Francisco
("City"), the Bay Area, and California.

6 (b) The Port is home to many of San Francisco's leading visitor destinations, and
7 welcomed over 24 million visitors annually before the COVID-19 pandemic.

8 (c) In furtherance of the City's recovery from the pandemic, the Port is committed to 9 supporting the growth of waterfront jobs and providing space for new and expanding 10 businesses on Port property, while maintaining public health and safety as well as scenic and 11 recreational opportunities.

(d) Vending, because it has a relatively low barrier to entry, encourages
entrepreneurship, represents a significant sector of San Francisco's local economy, and
provides economic opportunity for people to support themselves and their families, which is a
City priority.

16 (e) A well-regulated vending program would ensure the Port's streetscape can 17 remain a vibrant and dynamic marketplace, with unparalleled historic, scenic, and recreational 18 value that can be safely enjoyed by all. Regulations are needed for several reasons: to accommodate vending, including vendors' equipment, while safeguarding pedestrian and 19 20 chair-user movement on sidewalks, streets, and other public spaces; to prevent unsanitary 21 conditions and ensure trash and debris are removed by vendors; and to protect the scenic and natural character of the Port of San Francisco's parks and waterfront, and the recreational 22 23 opportunities the areas provide.

(f) In 2018, then-Governor Jerry Brown signed Senate Bill 946 ("SB 946"), which
 decriminalized street vending across California and constrained local regulatory authority. SB

946 seeks to create entrepreneurial and economic development opportunities for immigrant
 and low-income communities, increase access to desired goods, contribute to a safe and
 dynamic public space, and promote the safety and welfare of the public by encouraging local
 authorities to support and properly regulate vending.

The Board of Supervisors ("Board") seeks to prioritize health and safety, protect 5 (g) 6 the scenic and natural character of our City's parks and open spaces, and the waterfront, 7 while expanding economic opportunities for those who aspire to vend lawfully in a manner 8 consistent with SB 946. The Board recognizes that regulation of vending benefits the City as 9 a whole, as it leads to orderly commerce and safeguards public health. The Board seeks to provide vendors with the ability to operate in a safe, professional, and meaningfully 10 enforceable manner that enhances the visitor experience at the waterfront and provides 11 12 increased economic opportunities; and 13 (h) The Board seeks to create a vending program which provides permitting and 14 regulation of street vendors on Port property. 15 Section 3. The Port Code is hereby amended by adding Article 2A, to read as follows: 16 17 **ARTICLE 2A: PERMIT REGULATIONS FOR MOBILE VENDORS** 18 SEC. 2A.1. DEFINITIONS. 19 For the purpose of this Article 2A, the following words and phrases have the following 20 <u>meanings:</u> 21 Administrative Citation. An administrative fine for a violation of this Article 2A, as described 22 in Section 2A.8(b). 23 Certified Farmers' Market. A farmers' market operated in accordance with Health Code Section 440(d) and with Chapter 10.5 (commencing with section 47000) of Division 17 of the 24

1	City. The City and County of San Francisco.
2	Department. The Port.
3	<b>Director.</b> The Executive Director of the Port, or the Executive Director's designee.
4	Enforcement Official. Officers, employees, and contractors of the Port, and of such other
5	departments and agencies of the City, as designated by the Director.
6	Food. Any food, foodstuffs, or beverage for human consumption, and is inclusive of the
7	definitions of "Food" in Health Code Section 440(b) and in California Health and Safety Code section
8	<u>113781, as each may be amended.</u>
9	Merchandise. Any item that is not Food and that is not an art or craft regulated under Article
10	24 (Regulating Street Artists) of the Police Code.
11	Mobile Vendor. A person or entity that Vends Food or Merchandise from a pushcart, pedal-
12	driven cart, wagon, or other nonmotorized conveyance, or from one's person or a stand, display,
13	showcase, table, rack, or other movable structure. The term Mobile Vendor is comprised of each
14	Roaming Mobile Vendor and each Stationary Mobile Vendor, and includes but is not limited to a
15	Sidewalk Vendor as defined in California Government Code section 51036, as it may be amended from
16	time to time. If a Mobile Vendor Vends as an employee or agent of another person or entity, that
17	person or entity is also a Mobile Vendor.
18	Port. The Port of the City and County of San Francisco. Also, designated as the Department.
19	<b>Roaming Mobile Vendor.</b> A Mobile Vendor that moves from place to place and stops
20	intermittently to complete a Vending transaction.
21	Rules and Regulations. The Rules and Regulations of Mobile Vendors as described in Section
22	2A.5 of this Article.
23	Stationary Mobile Vendor. A Mobile Vendor that Vends from one or more fixed locations.
24	
25	

1	Swap Meet. A swap meet operated in accordance with Article 6 (commencing with section
2	21660) of Chapter 9 of Division 8 of the California Business and Professions Code, as it may be
3	amended, and any regulations adopted in accordance with that chapter.
4	Vend (and variations such as Vends, Vending). To sell, offer for sale, expose or display for
5	sale, solicit offers to purchase, or barter Food or Merchandise. Vending includes offering free samples
6	of Food or Merchandise that are also for sale, or negotiating fees for Food or Merchandise.
7	SEC. 2A.2. PERMIT REQUIRED; MANDATORY DISPLAY.
8	(a) No person may Vend on any property within the regulatory jurisdiction of the Port,
9	including a public right-of-way (as that term is defined in Public Works Code Section 2.4.4) or any
10	other street, sidewalk, alley, walkway, or pedestrian path available to the public, without first having
11	obtained either a Roaming Mobile Vendor permit or a Stationary Mobile Vendor permit pursuant to
12	this Article 2A.
13	(b) A Mobile Vendor shall prominently display a Mobile Vendor permit that corresponds
14	with the Mobile Vendor's business activity while Vending in accordance with this Article 2A.
15	<u>SEC. 2A.3. MOBILE VENDOR PERMIT TYPE.</u>
16	(a) Each Mobile Vendor permit must identify whether the permit authorizes the permittee to
17	Vend Food, Vend Merchandise, or Vend both Food and Merchandise.
18	(b) The Department may issue a time-limited Mobile Vendor permit to a nonprofit
19	corporation that is exempt from federal taxation under 26 U.S.C. section 501(c)(3), as it may be
20	amended, and which permit may apply to multiple Mobile Vendors as further described in the permit.
21	SEC. 2A.4. PERMIT APPLICATION; FEE.
22	(a) <b>Department Permit</b> . The Department shall establish a uniform application process
23	through which a Mobile Vendor may request, and upon approval receive, a Mobile Vendor permit. The
24	permit application shall require:
25	(1) The name, phone number, and current mailing address of the Mobile Vendor.

1	(2) A description of the Food and/or Merchandise to Vend.
2	(3) A certification by the Mobile Vendor that to their knowledge and belief, the
3	information submitted for the permit application is true.
4	(4) Proof of Identity, as described in Administrative Code Section 95.2 and as it may
5	be amended, of the Mobile Vendor.
6	(5) The California seller's permit number (California Department of Tax and Fee
7	Administration sales tax number), if applicable, of the Mobile Vendor.
8	(6) If the Mobile Vendor is an agent of an individual, company, partnership, or
9	corporation (each a "principal"), the name and business address of the principal.
10	(7) Any other information deemed relevant by the Department.
11	(b) Additional Permit Conditions.
12	(1) Each Mobile Vendor shall register with the Tax Collector pursuant to Article 12
13	(Business Registration) of the Business and Tax Regulations Code, if applicable. Separate fees may
14	apply and be payable to the Tax Collector.
15	(2) Each permit that applies to a Mobile Vendor that uses an energy source,
16	including propane, butane, or battery, is conditioned on the Mobile Vendor obtaining approval from
17	the Port Fire Marshal and complying with sections of the Fire Code that apply to the use of flammable
18	gas, flammable liquids, compressed gas, open flames, and other energy sources. Separate fees may
19	apply and be payable to the Port Fire Marshal.
20	(3) Each permit for Food Vending is conditioned on the Mobile Vendor obtaining a
21	permit to operate a food facility from the Department of Public Health pursuant to Health Code Section
22	452, as it may be amended. Separate fees may apply and be payable to the Department of Public
23	<u>Health.</u>
24	(4) Each Mobile Vendor permit issued pursuant to this Article 2A and the approval.
25	as applicable, of the Tax Collector (issuance of business registration certificate; see subsection $(b)(1)$ ),

1	Port Fire Marshal (see subsection (b)(2)), and the Department of Public Health (see subsection (b)(3)),
2	shall authorize inspection by the City of the Mobile Vendor's operations at any time during operating
3	<u>hours.</u>
4	(5) The applicable conditions of this subsection (b) are preconditions to the issuance
5	of a Mobile Vendor permit. Lapse or revocation of approvals, as applicable, from the Tax Collector,
6	Port Fire Marshal, or Department of Public Health shall, by operation of law, automatically invalidate
7	any Mobile Vendor permit without further action by the Department.
8	(c) <b>Permit Fee</b> . The Department shall identify the reasonable regulatory costs for the
9	administrative enforcement and any adjudication of this Article 2A, including but not limited to the
10	Department's costs to issue permits, perform investigations, conduct inspections, issue administrative
11	citations or other enforcement actions, and audit permittees. The Department shall charge applicants
12	for each Mobile Vendor permit and permit renewal an amount that does not exceed the reasonable
13	regulatory costs described in this subsection (c), and may include the actual costs that other agencies,
14	boards, commissions, or departments of the City incur in connection with the processing or
15	administration of this Article 2A, which fee shall be waived in accordance with California Business and
16	Professions Code section 16102, as it may be amended, and as applicable. The fee set forth in this
17	subsection (c) shall be approved by the Port Commission and may be adjusted each year, without
18	further action by the Board of Supervisors. In addition, separate annual fees may apply and be payable
19	to the Tax Collector, Department of Public Health, and the Port Fire Marshal for any approvals
20	required by each department.
21	(d) <b>Permit Expiration</b> . Each Mobile Vendor permit shall expire one year after issuance by
22	the Department unless renewed or unless the particular circumstances warrant a permit term of less
23	<u>than one year.</u>
24	(e) Permit Renewal.
25	

1	(1) Each Mobile Vendor permit may be renewed annually so long as the Mobile
2	Vendor remains in compliance with this Article 2A, including payment of all fees due to the City and
3	compliance with the Good Neighbor Policies.
4	(2) Each Mobile Vendor permit renewed by the Department is not operative unless
5	and until the Mobile Vendor has within 30 days of the date of renewal obtained approvals, as
6	applicable, from the Port Fire Marshal and the Department of Public Health.
7	(f) Application Denial; Appeal.
8	(1) The Department may reject an application for Mobile Vendor permit for any of
9	the following reasons: (A) the applicant failed to provide any required information or prerequisite
10	approvals identified in this Section 2A.4, or provided incorrect or incomplete information, and failed to
11	correct the application within a reasonable time identified by the Department; (B) the applicant
12	knowingly presented false and material information or knowingly omitted material information; (C) the
13	applicant previously received a permit, which permit was revoked pursuant to Section 2A.8, and the
14	revocation occurred within one year of the application; (D) the applicant submitted a substantially
15	similar application that was rejected within the past year; or (E) good cause, including but not limited
16	to violations of federal, state, or City law that in the Department's judgment are relevant to whether the
17	applicant would perform as a Mobile Vendor in a lawful manner.
18	(2) The rejection of an application for a Mobile Vendor permit may be appealed in
19	writing to the Director within 10 days of rejection. The Director may investigate the rejection and
20	consider any claims by the applicant, and shall either affirm or reverse the rejection within 30 days of
21	receipt of the written appeal.
22	SEC. 2A.5. VENDING RESTRICTIONS; DELEGATION OF AUTHORITY.
23	(a) Certified Farmer's Market or Swap Meet. No person, without written approval of the
24	Director, may Vend within the immediate vicinity of a permitted Certified Farmers' Market or a
25	permitted Swap Meet during the operating hours of that Certified Farmers' Market or Swap Meet.

1	(b) <b>Temporary Special Permit</b> . No person, without written approval of the Director, may
2	Vend within the immediate vicinity of a temporary special permit issued by the City, or any of its
3	departments or agencies, that authorizes the temporary use of, or encroachment on, the sidewalk or
4	other public area, including an encroachment permit, special event permit, or temporary event permit
5	for purposes including filming, parades, or outdoor concerts. This prohibition against Vending shall
6	be effective only for the limited duration of the temporary special permit. Any notice, business
7	interruption mitigation, or other rights provided to affected businesses or property owners under the
8	temporary special permit must also be provided to any Mobile Vendor specifically permitted by the
9	Director to operate in the immediate vicinity of the temporary special permit.
10	(c) Rules and Regulations Authorized.
11	(1) The Department, and any other agency (including but not limited to a
12	department or commission) of the City that governs the use of public property (including but not limited
13	to the Port Commission and its Executive Director), may adopt additional requirements regulating the
14	time, place, and manner of Vending if the requirements are directly related to objective health, safety,
15	or welfare concerns. Such Rules and Regulations may impose, but are not limited to imposing, (A)
16	further requirements to maintain sanitary conditions; or (B) requirements necessary to ensure
17	compliance with the Americans with Disabilities Act of 1990 (Public Law 101-336), as amended, and
18	other disability access standards.
19	(2) The Department, and any other agency (including but not limited to a
20	department or commission) of the City that governs the use of public property (including but not limited
21	to the Port Commission and its Executive Director) may prohibit Stationary Mobile Vendors from
22	Vending in a park if the operator of the park has signed an agreement for concessions that exclusively
23	permits Vending of Food, Merchandise, or both by one or more concessionaires.
24	(3) The Department, and any other agency (including but not limited to a
25	department or commission) of the City that governs the use of public property (including but not limited

1	to the Port Commission and its Executive Director), may adopt additional requirements regulating the
2	time, place, and manner of Vending in one or more parks if the requirements are: (A) directly related to
3	objective health, safety, or welfare concerns; or (B) necessary to ensure the public's use and enjoyment
4	of natural resources and recreational opportunities; or (C) necessary to prevent an undue
5	concentration of commercial activity that unreasonably interferes with the scenic and natural character
6	of the park.
7	SEC. 2A.6. EXEMPTIONS.
8	This Article 2A does not govern:
9	(a) the sale of an art or craft regulated under Article 24 (Regulating Street Artists) of the
10	<u>Police Code; or</u>
11	(b) the operation of, or any sale within, a Certified Farmers' Market; or
12	(c) the operation of, or any sale within, a permitted Swap Meet.
13	SEC. 2A.7. GOOD NEIGHBOR POLICIES.
14	Mobile Vendors shall operate in accordance with the following good neighbor policies:
15	(a) Mobile Vendors shall be individually responsible for any garbage, detritus, or debris
16	that directly results from their Vending activity;
17	(b) Noise and odors shall be contained within the immediate area of the Mobile Vendor so
18	as not to be a nuisance to neighbors; and
19	(c) Mobile Vendors shall urge patrons to not litter and to maintain the safety, cleanliness,
20	quiet, peace, and orderliness of the area; and
21	(d) Stationary Mobile Vendors shall provide for proper and adequate storage and disposal
22	of garbage, detritus, and debris.
23	SEC. 2A.8. ENFORCEMENT.
24	(a) Nuisance Declaration. Any violation of this Article 2A, or any applicable Rules and
25	<u>Regulations, constitutes a public nuisance.</u>

1	(b) Administrative Citation. Any Enforcement Official may issue an Administrative
2	Citation as described below for any violation of this Article 2A, or of the Rules and Regulations that
3	interpret and implement this Article, that occurs on a public right-of-way (as that term is defined in
4	Public Works Code Section 2.4.4) or any other street, sidewalk, alley, walkway, wharf, pier, or
5	pedestrian path available to the public:
6	(1) Vending that violates a requirement in this Article or in the Rules and
7	Regulations, other than failure to possess a valid license or permit:
8	(A) An administrative fine equal to \$100 for a first violation.
9	(B) An administrative fine equal to \$200 for a second violation within twelve
10	months of the first violation.
11	(C) An administrative fine equal to \$500 for a third violation, and each
12	subsequent violation, within twelve months of the first violation.
13	(D) In addition to any other authorized enforcement activity, a Mobile Vendor's
14	license and/or permit may be revoked or suspended for the remainder of its term upon a fourth or
15	subsequent violation.
16	(2) Vending without a valid license or permit:
17	(A) An administrative fine equal to \$250 for a first violation.
18	(B) An administrative fine equal to \$500 for a second violation within twelve
19	months of the first violation.
20	(C) An administrative fine equal to \$1,000 for a third violation, and each
21	subsequent violation, within twelve months of the first violation.
22	(D) Upon submission of proof of a valid permit, the administrative fines set forth
23	in subsections (A) through (C) of this subsection (b)(2) shall be reduced to equal the administrative
24	fines set forth in subsections (A) through (C) of subsection (b)(1), as those amounts may be revised
25	pursuant to subsection (b)(5).

1	(3) Failure to pay an Administrative Citation described in this subsection (b) shall
2	not be punishable as an infraction or misdemeanor; further, additional fines, fees, assessments, or any
3	other financial conditions beyond those authorized in this subsection (b) may not be assessed.
4	(4) When assessing an Administrative Citation authorized in this subsection (b), the
5	Director shall take into consideration the person's ability to pay the fine using the criteria described in
6	subsection (a) or (b) of California Government Code section 68632, as it may be amended. Notice
7	shall be given to the Mobile Vendor of the right to request an ability-to-pay determination and
8	instructions or other materials for requesting an ability-to-pay determination. The person may request
9	an ability-to-pay determination at adjudication or while the judgment remains unpaid, including when
10	a case is delinquent or has been referred to a comprehensive collection program. If the Mobile Vendor
11	meets the ability-to-pay criteria, the Department shall accept 20% of the total administrative fine
12	specified in subsection (b)(1) or (b)(2), as applicable, as full satisfaction.
13	(5) The amounts of the administrative fines identified in subsections (A) through (C)
14	of subsections (b)(1) and (b)(2) shall automatically increase or decrease to the maximum amount
15	authorized under California Government Code section 51039, as it may be amended. If section 51039
16	is repealed and not replaced with a similar limitation on administrative fines, then the administrative
17	fine amounts in this Section 2A.8 may be adjusted each year, without further action by the Board of
18	Supervisors, to reflect changes in the relevant Consumer Price Index.
19	(6) Within 10 days of issuance, the Administrative Citation must be paid unless a
20	written appeal is filed with the Director. The grounds of appeal are limited to error or abuse of
21	discretion in the issuance of the Administrative Citation. The Director may make an ability-to-pay
22	determination pursuant to subsection (b)(4), but inability to pay shall not be grounds for rescinding the
23	Administrative Citation or reducing the amount required to satisfy the fine to an amount less than the
24	amount specified in subsection (b)(4). The Director may investigate the Administrative Citation and
25	any claims by the appellant, and shall issue and mail a written decision on the appeal within 30 days of

1	receipt of the written appeal. Within 20 days of the Director's decision upholding a fine in whole or in
2	part, the Administrative Citation must be paid. The method for judicial review of an Administrative
3	Citation pursuant to subsection (b)(1) is an appeal filed with San Francisco Superior Court pursuant to
4	Government Code section 53069.4.
5	(7) Collection of Fines. The failure of any person to pay a fine assessed by
6	administrative citation within the required time constitutes a debt to the City. Simple interest at 10%
7	per year shall accrue on unpaid amounts. The City may file a civil action including a small claims
8	action or may pursue any other legal remedy to collect such money.
9	(c) Temporary Order to Cease Vending and Removal.
10	(1) Any Enforcement Official may order a Mobile Vendor to promptly cease Vending
11	when, in the judgment of the Enforcement Official, (A) the Mobile Vendor constitutes a safety hazard,
12	including but not limited to impeding the safe use of a public right of way by pedestrians and persons
13	with disabilities, or (B) when the presence of an emergency so requires, or (C) if the Mobile Vendor is
14	<u>unpermitted.</u>
15	(2) (A) After the Enforcement Official orders an unpermitted Mobile Vendor to
16	cease Vending, the Mobile Vendor must discontinue any Vending and remove all Food, Merchandise,
17	and any other Vending paraphernalia from property within the regulatory jurisdiction of the Port. A
18	failure to promptly obey any such orders from an Enforcement Official is a violation of this Article 2A
19	(B) After the Enforcement Official orders a permitted Mobile Vendor to cease
20	Vending, the Mobile Vendor must discontinue any Vending and follow the orders of the Enforcement
21	Official with regard to removing and relocating all Food, Merchandise, and any other Vending
22	paraphernalia, and any other orders the Enforcement Official may give to mitigate safety hazards, and
23	no further Vending may occur until the conditions that caused the order to cease Vending have been
24	abated to the satisfaction of the Enforcement Official. A failure to promptly obey any such orders from
25	an Enforcement Official is a violation of this Article 2A.

1	(3) If a Mobile Vendor fails, within a reasonable time, to remove Food, or
2	Merchandise, or any other Vending paraphernalia from the location subject to the order to cease
3	Vending, or to follow any other orders the Enforcement Official may issue to mitigate safety hazards,
4	the Enforcement Official may order the Department to remove any or all of the items. Prior to removal
5	by the Department, the Enforcement Official shall warn the Mobile Vendor of the impending removal
6	and impoundment, and shall urge the Mobile Vendor to make every effort to remove the items, or cause
7	their removal. Where the Department actually removes any items, the Enforcement Official shall issue
8	an Administrative Citation to the Mobile Vendor. The Mobile Vendor shall pay the actual costs of
9	removal and storage of any items impounded, and of disposal of any items the storage of which may
10	cause public health, safety, or infestation issues. The Mobile Vendor may contest the liability for these
11	costs by timely appealing the Administrative Citation. However, these actual costs to the City are not
12	subject to reduction based on the ability to pay; actual costs are a debt to the City that may be collected
13	in the same manner as provided in subsection (b)(7). Mobile Vendor items that have been removed and
14	stored may be recovered within 90 days from the date of removal and upon payment of a sum equal to
15	the costs of removal, plus any reasonable transport and storage costs, as determined by the
16	Department, and any costs incurred by the Department in disposing of any items contained in the
17	Mobile Food Facility.
18	(d) Other Violations. Any violation of this Article 2A, or of the Rules and Regulations that
19	interpret and implement this Article, that occurs on either: any area open to the public on private
20	property, or on public property other than a Public right-of-way (as that term is defined in Public
21	Works Code section 2.4.4) or any other street, sidewalk, alley, walkway or pedestrian path available to
22	the public, may be subject to one or more of the following:
23	(1) An administrative fine as described in subsection (b).
24	(2) Civil Action.
25

1	(A) The Department may refer violations to the City Attorney to maintain an
2	action for injunction to restrain to cause the correction or abatement of the violation of this Article 2A,
3	and for recovery of any City department's enforcement and abatement costs (including but not limited
4	to costs for removal, storage, impoundment, and disposal).
5	(B) The City shall be awarded its reasonable attorney's fees and costs incurred
6	in enforcing this Article 2A.

*It shall be unlawful for any peddler, huckster, or vendor of fish, vegetables, fruit, game, poultry, groceries, produce, dairy products, wood, candy, confectionery, racing tips and handicaps, tickets to*

18	in each direction parallel to the building line and thence at a 90 degree angle to the curb.
19	(6) Not be on any sidewalk adjacent to a curb which has been duly designated
20	pursuant to local ordinance or regulation as a white, yellow, blue, or red zone, or a bus zone.
21	(7) Not be within five feet of any crosswalk or fire hydrant.
22	(8) Leave unobstructed fire escapes, underneath and perpendicular from the
23	building to the street, five feet from both ends of the fire escape.
24	(9) Not be within five feet of inflammable liquid vents and fill pipes when tanks are
25	not being filled nor within 25 feet while tanks are being filled.

(b) No peddler shall peddle goods, wares or merchandise between the hours of 12:00 a.m.

- 2 (*midnight*) and 6:00 a.m. the following day.
- 3 (c) Notwithstanding any other provision of this Code, no peddler or pushcart peddler, as
- 4 *defined in Section 1330 of the San Francisco Police Code, shall peddle goods, wares or merchandise:*
- 5 (1) In any "P" district, as defined in Section 234 of the City Planning Code (Part II,

12	Francisco shall be granted unless the applicant has been issued a Certificate of Sanitation by the
13	Director of Public Health.
14	SEC. 869.9. PEDDLER EMPLOYEE.
15	No peddler may employ at any one time more than one peddler employee. The only exception to
16	this prohibition is employment by a peddler of persons who have peddler employee permits authorizing
17	employment by that peddler, which permits were issued prior to the effective date of this ordinance.
18	Every person desiring a peddler employee permit shall file an application with the Chief of Police upon
19	a form provided by said Chief of Police. Application shall be accompanied by:
20	(a) Signed statement from the permittee peddler verifying his intention to employ the
21	applicant, and indicating specific location where the peddler employee will peddle.
22	(b) Two photographs of the applicant 1"×1" in size.

3	SEC. 869.11. FEES PEDDLER AND PEDDLER EMPLOYEE.
4	Every applicant for a peddler or peddler employee permit shall pay a filing fee as specified in
5	Section 2.26 of Part II, Chapter VIII of the San Francisco Municipal Code (Police).
6	SEC. 869.12. PEDDLERS, PEDDLER EMPLOYEES, LICENSE FEE.
7	Every person granted a peddler permit or peddler employee permit to peddle goods, wares or
8	merchandise, or fish, vegetables or fruit, or food products for human consumption, or any other article
9	in any manner, shall pay to the Tax Collector an annual license fee. The license fee shall be paid
10	annually on or before March 31, in accordance with the provisions of Section 76.1 of the Business and
11	Tax Regulations Code. In calculating the fees earned herein by the Health Department pursuant to the
12	provisions of Section 6.402 of the Charter of the City and County of San Francisco, a percentage of the
13	license fee shall be credited to the Health Department pursuant to the annual determination by the

15	SEC. 869.13. LICENSE FEES – PRORATION SCHEDULE – DATE PAYABLE.

17	calendar year basis, prorated with regard to the calendar year on a monthly basis.
18	SEC. 869.14. PEDDLERS, FREE.
19	The Tax Collector may issue a free or gratuitous license to a person liable to pay the license tax

22	license was a soldier, sailor or marine of the United States who received an honorable discharge or a

#### Draft Executive Director ADMINISTRATIVE REGULATIONS for Mobile Vendors

### 1. <u>Authority; Purpose; and Effective Date</u>.

a. The following Administrative Regulations are promulgated by the Executive Director pursuant to Port Code section 2A.5 and Operational Standards section 5.

b. The purposes of the Administrative Regulations are to implement and provide site-specific application of the Operational Standards.

c. The Effective Date of the Administrative Regulations is \_\_\_\_\_.

#### 2. <u>Definitions</u>.

a. **Administrative Citation**. An administrative fine for a violation of this Article 2A, as described in Section 2A.8(b). (Port Code §2A.1.)

b. **Administrative Regulations** mean the rules and regulations of the Executive Director of the Port, as may be promulgated or amended from time to time, and which implement and provide site-specific application of the Operational Standards. (Op. Std. §2.a.)

c. **Certified Farmers' Market**. A farmers' market operated in accordance with Health Code Section 440(d) and with Chapter 10.5 (commencing with section 47000) of Division 17 of the California Food and Agricultural Code, as each may be amended, and any implementing regulations. (Port Code §2A.1.)

d. **City**. The City and County of San Francisco. (Port Code §2A.1.)

e. **Department**. The Port. (Port Code §2A.1.)

f. **Director**. The Executive Director of the Port, or the Executive Director's designee. (Port Code §2A.1.)

g. **Enforcement Official**. Officers, employees, and contractors of the Port, and of such other departments and agencies of the City, as designated by the Director. (Port Code §2A.1.)

h. **Food**. Any food, foodstuffs, or beverage for human consumption, and is inclusive of the definitions of "Food" in Health Code Section 440(b) and in California Health and Safety Code section 113781, as each may be amended. (Port Code §2A.1.)

ADMINISTRATIVE REGULATIONS for Mobile Vendors

i. **Merchandise**. Any item that is not Food and that is not an art or craft regulated under Article 24 (Regulating Street Artists) of the Police Code. (Port Code §2A.1.)

j. **Mobile Vendor**. A person or entity that Vends Food or Merchandise from a pushcart, pedal-driven cart, wagon, or other nonmotorized conveyance, or from one's person or a stand, display, showcase, table, rack, or other movable structure. The term Mobile Vendor is comprised of each Roaming Mobile Vendor and each Stationary Mobile Vendor, and includes but is not limited to a Sidewalk Vendor as defined in California Government Code section 51036, as it may be amended from time to time. If a Mobile Vendor Vends as an employee or agent of another person or entity, that person or entity is also a Mobile Vendor. (Port Code §2A.1.)

k. **Operational Standards** mean the guidelines and general standards applicable to Mobile Vendors as approved from time to time by the Port Commission. (Op. Std. §2.b.)

I. **Port**. The Port of the City and County of San Francisco. Also, designated as the Department. (Port Code §2A.1.)

m. **Roaming Mobile Vendor**. A Mobile Vendor that moves from place to place and stops intermittently to complete a Vending transaction. (Port Code §2A.1.)

n. **Rules and Regulations**. The Rules and Regulations of Mobile Vendors as described in Section 2A.5 of this Article. (Port Code §2A.1.)

o. **Stationary Mobile Vendor**. A Mobile Vendor that Vends from one or more fixed locations. (Port Code §2A.1.)

p. **Swap Meet**. A swap meet operated in accordance with Article 6 (commencing with section 21660) of Chapter 9 of Division 8 of the California Business and Professions Code, as it may be amended, and any regulations adopted in accordance with that chapter. (Port Code §2A.1.)

q. **Vend** (and variations such as Vends, Vending). To sell, offer for sale, expose or display for sale, solicit offers to purchase, or barter Food or Merchandise. Vending includes offering free samples of Food or Merchandise that are also for sale, or negotiating fees for Food or Merchandise. (Port Code §2A.1.)

r. **Vending Equipment** means all of the materials that a Mobile Vendor uses to Vend in accordance with Section 6 of the Administrative Regulations. Vending Equipment includes but is not limited to a pushcart, pedal-driven cart, wagon, or other nonmotorized conveyance, a stand, display, showcase, table, rack, or other movable structure, and any boxes or storage devices containing Food or Merchandise.

# 3. Permits.

a. The Real Estate Division of the Port will issue vendor permits through a uniform application process.

b. <u>Permit Required; Mandatory Display</u>. (Port Code §2A.2.)

(a) No person may Vend on any property within the regulatory jurisdiction of the Port, including a public right-of-way (as that term is defined in Public Works Code Section 2.4.4) or any other street, sidewalk, alley, walkway, or pedestrian path available to the public, without first having obtained either a Roaming Mobile Vendor permit or a Stationary Mobile Vendor permit pursuant to this Article 2A.

(b) A Mobile Vendor shall prominently display a Mobile Vendor permit that corresponds with the Mobile Vendor's business activity while Vending in accordance with this Article 2A.

c. <u>Mobile Vendor Permit Type</u>. (Port Code §2A.3.)

(a) Each Mobile Vendor permit must identify whether the permit authorizes the permittee to Vend Food, Vend Merchandise, or Vend both Food and Merchandise.

(b) The Department may issue a time-limited Mobile Vendor permit to a nonprofit corporation that is exempt from federal taxation under 26 U.S.C. section 501(c)(3), as it may be amended, and which permit may apply to multiple Mobile Vendors as further described in the permit.

(c) A Mobile Vendor permit authorizing the permittee to Vend either Merchandise or Food and Merchandise may also Vend an art or craft regulated under Article 24 (Regulating Street Artists) of the Police Code if the Mobile Vendor has obtained a Street Artist Certificate under Article 24 of the Police Code.

d. <u>Permit Fee</u>. (Op. Std. §4.)

The Port shall collect an annual permit fee pursuant to Port Code Section 2A.4, equal to One Hundred Dollars (\$100). Separate annual fees may apply and be payable to the Tax Collector, Department of Public Health, and the Port Fire Marshal for any approvals required by each department.

e. <u>Permit Application</u>. (Port Code §2A.4.)

(a) ... The permit application shall require:

(1) The name, phone number, and current mailing address of the Mobile Vendor.

(2) A description of the Food and/or Merchandise to Vend.

(3) A certification by the Mobile Vendor that to their knowledge and belief, the information submitted for the permit application is true.

(4) Proof of Identity, as described in Administrative Code Section 95.2 and as it may be amended, of the Mobile Vendor.

(5) The California seller's permit number (California Department of Tax and Fee Administration sales tax number), if applicable, of the Mobile Vendor.

(6) If the Mobile Vendor is an agent of an individual, company, partnership, or corporation (each a "principal"), the name and business address of the principal.

(7) Any other information deemed relevant by the Department.

(b) Additional Permit Conditions.

(1) Each Mobile Vendor shall register with the Tax Collector pursuant to Article 12 (Business Registration) of the Business and Tax Regulations Code, if applicable. Separate fees may apply and be payable to the Tax Collector.

(2) Each permit that applies to a Mobile Vendor that uses an energy source, including propane, butane, or battery, is conditioned on the Mobile Vendor obtaining approval from the Port Fire Marshal and complying with sections of the Fire Code that apply to the use of flammable gas, flammable liquids, compressed gas, open flames, and other energy sources. Separate fees may apply and be payable to the Port Fire Marshal.

(3) Each permit for Food Vending is conditioned on the Mobile Vendor obtaining a permit to operate a food facility from the Department of Public Health pursuant to Health Code Section 452, as it may be amended. Separate fees may apply and be payable to the Department of Public Health.

(4) Each Mobile Vendor permit issued pursuant to this Article 2A and the approval, as applicable, of the Tax Collector (issuance of business registration certificate; see subsection (b)(1)), Port Fire Marshal (see subsection (b)(2)), and the Department of Public Health (see subsection (b)(3)), shall authorize inspection by the City of the Mobile Vendor's operations at any time during operating hours.

(5) The applicable conditions of this subsection (b) are preconditions to the issuance of a Mobile Vendor permit. Lapse or revocation of approvals, as applicable, from the Tax Collector, Port Fire Marshal, or Department of Public Health shall, by operation of law, automatically invalidate any Mobile Vendor permit without further action by the Department.

f. <u>Additional Port Permit Requirements</u>.

Pursuant to Port Code sections 2A.4(a)(7) and 2A.4(f)(1)(e), the following requirements, if applicable, are additional preconditions to the issuance of a Mobile Vendor permit. Lapse or revocation of applicable approvals or requirements described below shall, by operation of law, automatically invalidate any Mobile Vendor permit without further action by the Port.

(1) Each Mobile Vendor permit issued pursuant to Article 2A of the Port Code shall require the Mobile Vendor to procure and maintain insurance in coverages and amounts as determined by the City's Risk Manager.

(2) Each Mobile Vendor permit issued pursuant to Article 2A of the Port Code shall require any Mobile Vendor that Vends an art or craft regulated under Article 24 (Regulating Street Artists) of the Police Code shall obtain a Street Artist Certificate in accordance with Article 24 of the Police Code.

g. <u>Permit Expiration</u>. (Port Code §2A.4(d).)

#### ADMINISTRATIVE REGULATIONS for Mobile Vendors

Each Mobile Vendor permit shall expire one year after issuance by the Department unless renewed or unless the particular circumstances warrant a permit term of less than one year.

### 4. Vending Hours of Operations.

Vending shall be permitted between the hours of 8:00 am to 9:00 pm in order to maintain the scenic nature and facilitate the public's use and enjoyment of the San Francisco Bay and recreational opportunities. (Op. Std. §3.e.)

## 5. <u>Vending Location</u>.

a. To immediately implement Operational Standards 3.a and 3.b, Stationary Mobile Vendors will only be permitted in designated vending locations established by markings on the pavement, and identified on a map posted on the Port's website.

b. Stationary Vending locations may be used on a first come, first served basis.

c. Port will explore a procedure to allocate stationary Vending locations to permitted Stationary Mobile Vendors. Port shall seek feedback about an allocation procedure and collaborate with Mobile Vendors before implementing or enforcing an allocation process.

d. <u>Certified Farmer's Market or Swap Meet</u>. (Port Code §2A.5(a).)

No person, without written approval of the Director, may Vend within the immediate vicinity of a permitted Certified Farmers' Market or a permitted Swap Meet during the operating hours of that Certified Farmers' Market or Swap Meet.

e. <u>Temporary Special Permit</u>. (Port Code §2A.5(b).)

No person, without written approval of the Director, may Vend within the immediate vicinity of a temporary special permit issued by the City, or any of its departments or agencies, that authorizes the temporary use of, or encroachment on, the sidewalk or other public area, including an encroachment permit, special event permit, or temporary event permit for purposes including filming, parades, or outdoor concerts. This prohibition against Vending shall be effective only for the limited duration of the temporary special permit. Any notice, business interruption mitigation, or other rights provided to affected businesses or property owners under the temporary special permit must also be provided to any Mobile Vendor specifically permitted by the Director to operate in the immediate vicinity of the temporary special permit.

# 6. <u>Vending Equipment</u>.

ADMINISTRATIVE REGULATIONS for Mobile Vendors

a. Vending is restricted to non-motorized conveyances, stands, or pushcarts. Vending is not allowed from an automobile regardless of whether the automobile is parked in a lawful parking space. (Port Code §2A.1.)

b. Vending Equipment may not be more than 10 feet in length, 10 feet in depth, and 10 feet in height, including wheels, axles, umbrellas, tents, or canopies, and other appurtenances. When in use, the umbrella, tent, or canopy shall not exceed 10 feet in height as measured from ground level to its highest point. The umbrella, tent, or canopy must be made of a sturdy and safe material and must be attached and anchored to the Vending Equipment in such a way that sudden bursts of wind will not dislodge it. (Op. Std. §§3.a. & 3.b.)

c. A Roaming Mobile Vendor may have no more than one (1) umbrella that complies with the requirements in Administrative Regulation Section 6.b. The umbrella cannot be attached to any public or private fixture, such as the sidewalk, street furniture, fence, rail, bench, bike rack, tree, pole, sign, or other publicly-owned object. (Op. Std.  $\S$ 3.a. & 3.b.)

d. No connection to external power, piping, or plumbing is allowed. The Vending Equipment must be entirely self-contained.

e. Signage is permitted only if attached to the Vending Equipment or the Mobile Vendor's person. Signage may not be attached to any public or private fixture, such as the sidewalk, street furniture, fence, rail, bench, bike rack, tree, pole, sign, or other publicly-owned object. (Op. Std.  $\S$ 3.a – 3.b.)

f. Vending Equipment must not lean against or attach to a permanent building or structure.

g. Each Stationary Mobile Vendor shall be limited to two (2) chairs. The chairs may be placed behind or next to (but not in front of) the Vending Equipment. (Op. Std. §3.a.)

h. Mobile Vendors are prohibited from placing Vending Equipment in a parking stall or a designated parking area for automobiles, bicycles, scooters, pedicabs or other mobility devices. (Op. Std.  $\S$ 3.a – 3.c.)

i. Food and Merchandise must be securely fastened to or secured within the Vending Equipment. Mobile Vendors must ensure that sudden bursts of wind will not dislodge Food or Merchandise. (Op. Std.  $\S$ 3.a – 3.c.)

j. Mobile Vendors shall not leave Vending Equipment, or Food or Merchandise, unattended. For the purposes of these Administrative Regulations, unattended means that the Mobile Vendor is not within 10 feet of the Vending Equipment and/or the Food or Merchandise.

#### ADMINISTRATIVE REGULATIONS for Mobile Vendors

k. Vending Equipment shall not be chained or fastened to the sidewalk, street furniture, fence, rail, bench, bike rack, tree, pole, sign, or other publicly-owned object. (Op. Std. §§3.a – 3.c.)

I. Mobile Vendors must display their Port-issued Mobile Vendor permit on their Vending Equipment when operating. To the greatest extent feasible, the Permit shall be placed on the upper left-hand corner of Vending Equipment on the side that faces the public or is nearest the path of pedestrian travel. (Port Code §2A.2(b).)

m. Mobile Vendors must maintain, possess, and display or show all local authority permits required by either the State or City.

n. Food or Merchandise shall not be displayed directly upon a street, sidewalk, pathway, pier, wharf, or grass or landscaping, or other structure (street furniture, fence, rail, bench, bike rack, tree, pole, sign, or other publicly-owned object), or any public place. (Op. Std.  $\S$ 3.a – 3.b.)

o. Stationary Vending Equipment shall be parallel to the curb, with the longest side of the Vending Equipment parallel to the curb.

p. Stationary Mobile Vendors shall store any Food and Merchandise, and any accessory items entirely within or beneath the Vending Equipment. Food, merchandise, and any accessory items shall not be stored or piled alongside, behind, or in front of the Vending Equipment. (Op. Std.  $\S$ 3.a – 3.b.)

q. In addition to prohibitions on the sale of alcohol, ammunition, animals, counterfeit goods, firearms, or tobacco, which exist in local, state, or federal law, Mobile Vendors are prohibited from Vending any harmful or dangerous items or noise-making devices. (Op. Std.  $\S$ 3.a – 3.b.)

r. No Mobile Vendor may Vend in any location that would reduce the clear path of travel below the minimum needed to allow adequate circulation. This minimum clearance shall be 16 feet on the Embarcadero Promenade due to its high pedestrian volumes, or 6 feet elsewhere on Port property.

s. All applicable parking regulations shall be observed.

t. Due to high pedestrian volume, no Mobile Vendor may Vend within any Port property within the Oracle Park Special Event Area defined by SFMTA during the two hours immediately before an event and the two hours immediately after an event, unless written consent from SFMTA is first obtained.

u. Mobile Vendors shall not make excessive noise and are prohibited from using speakers, amplifiers, musical instruments, or noise-making devices. (Op. Std.  $\S$ 3.a – 3.b.)

### 7. <u>Energy Sources</u>.

a. No Mobile Vendor shall use any power source that poses a fire or public safety hazard, any generator, or wet cell battery with removable fill caps. (Op. Std.  $\S$ 3.a – 3.b.)

b. No Mobile Vendor shall connect to any building, vehicle, or any City or Port power source. (Op. Std.  $\S$ 3.a – 3.b.)

### 8. <u>Trash, Recycle, Compost, and Other Debris</u>.

a. Mobile Vendors are responsible for clean-up and removal of any Food or Merchandise, and any item, package, refuse, waste, litter or other materials occurring because of or related to Vending Food or Merchandise.

b. Mobile Vendors are prohibited from placing any liquid or solid waste, or debris of any kind, in Port trash, recycle, or compost receptacles.

c. Mobile Vendors must bring their own vermin-proof trash receptacles and remove any and all waste, refuse and litter collected or discarded as a result of preparing, selling or consuming food items or merchandise on Port property.

## 9. <u>Good Neighbor Policies</u>. (Port Code §2A.7.)

Mobile Vendors shall operate in accordance with the following good neighbor policies:

(a) Mobile Vendors shall be individually responsible for any garbage, detritus, or debris that directly results from their Vending activity;

(b) Noise and odors shall be contained within the immediate area of the Mobile Vendor so as not to be a nuisance to neighbors; and

(c) Mobile Vendors shall urge patrons to not litter and to maintain the safety, cleanliness, quiet, peace, and orderliness of the area; and

(d) Stationary Mobile Vendors shall provide for proper and adequate storage and disposal of garbage, detritus, and debris.

## 10. <u>Enforcement and Appeals</u>. (Port Code §2A.8.)

(a) <u>Nuisance Declaration</u>. Any violation of this Article 2A, or any applicable Rules and Regulations, constitutes a public nuisance.

(b) <u>Administrative Citation</u>. Any Enforcement Official may issue an Administrative Citation as described below for any violation of this Article 2A, or of the Rules and Regulations that interpret and implement this Article, that occurs on a public right-of-way (as that term is defined in Public Works Code Section 2.4.4) or any other street, sidewalk, alley, walkway, wharf, pier, or pedestrian path available to the public: ADMINISTRATIVE REGULATIONS

for

Mobile Vendors

(1) Vending that violates a requirement in this Article or in the Rules and Regulations, other than failure to possess a valid license or permit:

(A) An administrative fine equal to \$100 for a first violation.

(B) An administrative fine equal to \$200 for a second violation within twelve months of the first violation.

(C) An administrative fine equal to \$500 for a third violation, and each subsequent violation, within twelve months of the first violation.

(D) In addition to any other authorized enforcement activity, a Mobile Vendor's license and/or permit may be revoked or suspended for the remainder of its term upon a fourth or subsequent violation.

(2) Vending without a valid license or permit:

(A) An administrative fine equal to \$250 for a first violation.

(B) An administrative fine equal to \$500 for a second violation within twelve months of the first violation.

(C) An administrative fine equal to \$1,000 for a third violation, and each subsequent violation, within twelve months of the first violation.

(D) Upon submission of proof of a valid permit, the administrative fines set forth in subsections (A) through (C) of this subsection (b)(2) shall be reduced to equal the administrative fines set forth in subsections (A) through (C) of subsection (b)(1), as those amounts may be revised pursuant to subsection (b)(5).

(3) Failure to pay an Administrative Citation described in this subsection (b) shall not be punishable as an infraction or misdemeanor; further, additional fines, fees, assessments, or any other financial conditions beyond those authorized in this subsection (b) may not be assessed.

(4) When assessing an Administrative Citation authorized in this subsection (b), the Director shall take into consideration the person's ability to pay the fine using the criteria described in subsection (a) or (b) of California Government Code section 68632, as it may be amended. Notice shall be given to the Mobile Vendor of the right to request an ability-to-pay determination and instructions or other materials for requesting an ability-to-pay determination. The person may request an ability-to-pay determination at adjudication or while the judgment remains unpaid, including when a case is delinquent or has been referred to a comprehensive collection program. If the Mobile Vendor meets the ability-to-pay criteria, the Department shall accept 20% of the total administrative fine specified in subsection (b)(1) or (b)(2), as applicable, as full satisfaction.

(5) The amounts of the administrative fines identified in subsections (A) through (C) of subsections (b)(1) and (b)(2) shall automatically increase or decrease to the maximum amount authorized under California Government Code section 51039, as it may be amended. If section 51039 is repealed and not replaced with a similar limitation on administrative fines, then the administrative fine amounts in this Section 2A.8 may be adjusted each year, without further action by the Board of Supervisors, to reflect changes in the relevant Consumer Price Index.

(6) Within 10 days of issuance, the Administrative Citation must be paid unless a written appeal is filed with the Director. The grounds of appeal are limited to error or abuse of discretion in the issuance of the Administrative

Citation. The Director may make an ability-to-pay determination pursuant to subsection (b)(4), but inability to pay shall not be grounds for rescinding the Administrative Citation or reducing the amount required to satisfy the fine to an amount less than the amount specified in subsection (b)(4). The Director may investigate the Administrative Citation and any claims by the appellant, and shall issue and mail a written decision on the appeal within 30 days of receipt of the written appeal. Within 20 days of the Director's decision upholding a fine in whole or in part, the Administrative Citation must be paid. The method for judicial review of an Administrative Citation pursuant to subsection (b)(1) is an appeal filed with San Francisco Superior Court pursuant to Government Code section 53069.4.

(7) Collection of Fines. The failure of any person to pay a fine assessed by administrative citation within the required time constitutes a debt to the City. Simple interest at 10% per year shall accrue on unpaid amounts. The City may file a civil action including a small claims action or may pursue any other legal remedy to collect such money.

(c) <u>Temporary Order to Cease Vending and Removal</u>.

(1) Any Enforcement Official may order a Mobile Vendor to promptly cease Vending when, in the judgment of the Enforcement Official, (A) the Mobile Vendor constitutes a safety hazard, including but not limited to impeding the safe use of a public right of way by pedestrians and persons with disabilities, or (B) when the presence of an emergency so requires, or (C) if the Mobile Vendor is unpermitted.

(2) (A) After the Enforcement Official orders an unpermitted Mobile Vendor to cease Vending, the Mobile Vendor must discontinue any Vending and remove all Food, Merchandise, and any other Vending paraphernalia from property within the regulatory jurisdiction of the Port. A failure to promptly obey any such orders from an Enforcement Official is a violation of this Article 2A

(B) After the Enforcement Official orders a permitted Mobile Vendor to cease Vending, the Mobile Vendor must discontinue any Vending and follow the orders of the Enforcement Official with regard to removing and relocating all Food, Merchandise, and any other Vending paraphernalia, and any other orders the Enforcement Official may give to mitigate safety hazards, and no further Vending may occur until the conditions that caused the order to cease Vending have been abated to the satisfaction of the Enforcement Official. A failure to promptly obey any such orders from an Enforcement Official is a violation of this Article 2A.

(3) If a Mobile Vendor fails, within a reasonable time, to remove Food, or Merchandise, or any other Vending paraphernalia from the location subject to the order to cease Vending, or to follow any other orders the Enforcement Official may issue to mitigate safety hazards, the Enforcement Official may order the Department to remove any or all of the items. Prior to removal by the Department, the Enforcement Official shall warn the Mobile Vendor of the impending removal and impoundment, and shall urge the Mobile Vendor to make every effort to remove the items, or cause their removal. Where the Department actually removes any items, the Enforcement Official shall issue an

Administrative Citation to the Mobile Vendor. The Mobile Vendor shall pay the actual costs of removal and storage of any items impounded, and of disposal of any items the storage of which may cause public health, safety, or infestation issues. The Mobile Vendor may contest the liability for these costs by timely appealing the Administrative Citation. However, these actual costs to the City are not subject to reduction based on the ability to pay; actual costs are a debt to the City that may be collected in the same manner as provided in subsection (b)(7). Mobile Vendor items that have been removed and stored may be recovered within 90 days from the date of removal and upon payment of a sum equal to the costs of removal, plus any reasonable transport and storage costs, as determined by the Department, and any costs incurred by the Department in disposing of any items contained in the Mobile Food Facility.

## 11. <u>Amendment, Replacement, and Waiver of Administrative Regulations</u>.

a. The Executive Director may amend, replace, or otherwise alter any of the Administrative Regulations in conformance with local and state law at any time and as needed to further the purposes of the Operational Standards, Article 2A of the Port Code, and in accordance with state law. Note, the following sections of the Administrative Regulations are excerpts of the Port Code or Operational Standards and may not be amended by the Executive Director: 2.a - 2.q, 3.b - 3.d (excluding 3.c(c)), 3.g, 5.d - 5.e, 9, and 10, inclusive. (Op. Std. §5.a.)

b. Any revisions to the Administrative Regulations shall not take effect until the Administrative Regulations have been published on the Port's website and adequate signage informing the public and Mobile Vendors of the applicable Administrative Regulations are posted. (Op. Std. §5.b.)

c. The Executive Director may temporarily waive application of any Administrative Regulation. Waiver shall be documented in writing and identify how the waiver implements or furthers one or more of the purposes of the Operational Standards or of local or state law.
