

#### VICINITY MAP




### AREA OF WORK LOCATION MAP



#### 1.1 SUMMARY

#### 1.2 DESCRIPTION OF BID ITEMS

#### A. Bid Items:

Bid Item 1: Mobilization and Demobilization

The lump sum price for Mobilization and Demobilizations, which is capped at a maximum of 5% of the sum of bid items 2 through 13, shall cover all costs for all items, including labor, supervision, management, materials and equipment, for Work described in Section 01 21 50, and all General Conditions and incidental items not included in other bid items.

2. Bid Item 2: Construction Surveys

This lump sum price shall cover all costs, including labor, design, supervisions, management, materials, and equipment for Work related to the following Topographic Surveys described in Section 02 39 00:

- Pre-Construction Record Survey
- Interim Surveys
- Post-Construction Record Survey
- 3. Bid Item 3: Site Clearing and Demolition

This lump sum price shall cover all costs, including labor, design, supervision, management, materials, and equipment for Work related to Site Clearing and Demolition, including, but not limited to removal and offsite disposal of the following:

- Vegetation from temporary access routes
- Driftwood and other marine debris within the limits of work at time of bid (not shown on Drawings)
- Any other item requiring removal as shown on the Drawings
- 4. Bid Item 4: Temporary Construction Access and Environmental Protection

This lump sum price shall cover all costs, including labor, design, supervision, management, materials and equipment for Work related to Temporary Construction Access and Environmental Protection, including but not limited to:

- All improvements to existing roads, trails, public access amenities, fencing, sidewalks, and other existing infrastructure to accommodate construction equipment access
- Establishment of construction staging areas, including temporary power and water, restroom facilities and construction offices
- Temporary gates, fencing and signage
- Staking and flagging of temporary construction access routes
- Placement and maintenance of crane mats or other temporary fill to facilitate vehicle access across upland and tidal marsh habitat areas
- Placement and maintenance of beach fill material to facilitate vehicle access along gravel beach
- Compliance with all requirements for the protection of protected habitats and species
- Bid Item 5: SWPPP Compliance

This lump sum price shall cover all costs, including labor, design, supervision, management, materials, and equipment for Work related to the Storm Water Pollution Prevention Plan Compliance, including, but not limited to:

- Preparation and submittal of a Stormwater Pollution Prevention Plan (SWPPP)
- Implementation of all necessary measures to comply with the SWPPP
- Bid Item 6: Main Beach Fill Placement

This unit cost price per cubic yard shall cover all costs, including labor, design, supervision, management, materials, and equipment for Work related to construction of the portion of Gravel Beach. The City will be supplying the material at a nearby site. Total volume (in CY) to be measured by the City based on the Pre-Construction Survey of stockpiled material, less the volume of material placed outside of tolerance. #### Bid Item 7: Natural Sand

This unit cost price per ton shall cover all costs, including labor, design, supervision, management, materials, and equipment for Work related to the imported sand portion of the Special High Marsh Gravel-Sand Mix. Total weight (in tons) to be measured by Contractor using certified scales, verified using Interim and Post-Construction Surveys. Work to be performed includes, but is not limited to the purchase, hauling, mixing and placement of Special High Marsh Gravel-Sand Mix.

8. Bid Item 8: Low Permeability Sill

This lump sum price shall cover all costs, including labor, design, supervision, management, materials and equipment for Work related to the placement and construction of the Low Permeability Sills, including salvaging native soil and/or importing soil, importing bedding material, mixing, placement and shaping.

9. Bid Item 9: Groynes and Headlands

This lump sum price shall cover all costs, including labor, design, supervision, management, materials and equipment for Work related to the construction of the two "Groyne and Headland" rock stabilization structures, as specified and shown on the drawings and in the project manual. Work to be performed includes, but is not limited to the following:

- Subgrade preparation
- Construction of the rock stabilization structures
- 10. Bid Item 10: Drift Sills

This lump sum price shall cover all costs, including labor, design, supervision, management, materials and equipment for Work related to the construction of the three "Drift Sills" rock stabilization structures, as specified and shown on the drawings and in the project manual. Work to be performed includes, but is not limited to the following:

- Subgrade preparation
- Construction of the rock stabilization structures
- 11 Bid Item 11: Site Restoration General

This lump sum price shall cover all costs, including labor, design, supervision, management, materials, and equipment for Work related to Site Restoration, as specified, and shown on the drawings and in the

project manual. Work to be performed includes, but is not limited to the following:

- Restoration of vegetation and habitat features damaged in the course of the Work, including in staging areas and along construction access routes
- Restoration of bollards, fencing, benches, signage, and other public access fixtures and amenities
- Bid Item 12: Site Restoration AC Path

This unit cost price per linear foot shall cover all costs, including labor, design, supervision, management, materials, and equipment for Work related to repaying damaged colored asphalt concrete paths, as specified, and shown on the drawings and in the project manual.

Bid Item 13: Site Restoration – DG Path

This unit cost price per square foot shall cover all costs, including labor, design, supervision, management, materials, and equipment for Work related to repaying damaged decomposed granite paths, as specified, and shown on the drawings and in the project manual.

Bid Item 14: Environmental Allowance: Ridgway's Rail

A preset allowance as shown in the Bid Form will be paid as directed by the City Representative. It is possible that some or all of the preset allowance amount may be used. This allowance is for work associated with costs, including labor, design, supervision, management, materials, and equipment for environmental mitigation work that is conditional on the bird Ridgway Rail being detected on site:

- Portable acoustic barriers at the western edge of the east marsh access and stockpile area, required by Spec 01 57 19, 1.12
- Additional mitigation measures required by Spec 01 57 19 if contract work goes beyond January 31
- Bid Item 15: Partnering Allowance

The Partnering allowance is set at \$15,000, and shall cover 100% of all costs including labor, supervision, management, materials and equipment, and as described in Section 01 31 33, Partnering Requirements.

#### 1.3 DESCRIPTION OF ADDITIVE ALTERNATE BID ITEMS

A. Additive Alternate Bid Item A1, Wood Habitat Structures:

This unit cost price shall cover all costs, including labor, design, supervision, management, materials and equipment for Work related to the installation of each of up to 20 Wood Habitat Structures, as specified and shown on the drawings and in the project manual. Work to be performed includes, but is not limited to the following:


- Handling and placement of large wood elements provided by the City at a nearby site, including staking, trenching and any necessary trimming and other field fitting
- Placement of rounded coble material to embed and stabilize large wood
- B. Additive Alternate Bid Item A2, Oyster Reef Ball Installation:

- Transport of ORB elements from Pier 94 stockpile location to project site
- Placement of ORB elements on sea-bed as shown on plans

The Port of San Francisco (the "Port") announces an Invitation for Bids ("IFB") for construction on HERON'S HEAD SHORELINE RESILIENCE in San Francisco, CA. The scope of work is to 1) construct temporary construction access roads to the marsh area, 2) construction a new stabilized shoreline by placing coarse sand and gravel stabilized by rock and cobble groynes, 3) install reclaimed-wood habitat structures for wildlife (Additive Bid Alternates), 4) Install Oyster Reef Balls (Additive Bid Alternates) and 5) restore the site to previous conditions along the access routes, including but not limited to: repaving, removal of temporary fill, and replanting. Time is of the essence (TOE) for the completion of the earthwork and fill placement in the intertidal zone, work listed under Bid Items 6 through 10 of the Bid Schedule. The Port stands to lose funding if the Work is not on time. Assuming the CITY issues the Notice to Proceed on July 15, 2022, the







- Employ apprentices registered in a DIR-approved apprenticeship program and with the Department of Labor (DOL). Submit DIR apprentice certifications and DOLapproved apprentice certifications into LCPtracker. CA Labor Code §1777.5; 29 CFR 5.5(a)(4)(i)
- Post the applicable Davis-Bacon wage determination with the Davis-Bacon poster (WH- 1321) and OLSE prevailing wage poster on the jobsite in a prominent and accessible place. SF Administrative Code 6.22(e)(7)(D); 48 CFR § 22.404-10

- Register with the DIR. CA State Labor Code §1725.5
- Comply with local labor laws including Minimum Compensation Ordinance, Health Care Accountability Ordinance, Health Care Security Ordinance, Fair Chance Ordinance and miscellaneous Prevailing Wage Ordinances where applicable. SF Administrative Code Ch. 14, 12P, 12Q, 12T and 21C

All work is subject to compliance monitoring and enforcement by the San Francisco Office of Labor Standards Enforcement (OLSE). SFAdministrative Code 6.24 and 6.22(e)(7)(A)

OLSE Compliance Officers have the right to engage in random inspections of job sites and to have access to the employees of the contractor, employee time sheets, inspection logs, payroll records and employee paychecks. SFAdministrative Code 6.22(e)(7)(B)
