CURRENT SOUTH BEACH HARBOR WAIT LIST POLICIES:

- **NO LIVEBOARD ALLOWED!!!**
- Credit Checks are required prior to berthing. Prior berthing locations and references may be requested.
- **An annual non-refundable fee of \$100** - No deposit required. Wait applicants are expected to make prompt annual fee payments noting their account number. **NO CASH ACCEPTED.**
- Removal from the list will result in the forfeiture of all paid fees.
- Payment should be made every year no later than 15th of respective Due Month.
- 10% Late Fees will apply, if we don't receive the Payment on time.
- Nonpayment of fees for 4 months after the Due month will result in Removal from the waitlist.
- Wait applicant updates: Phone numbers, Email, and address notification to SBH when changed.
- Berth holders can pay \$75 a year to get on an internal move list to change the berth size and/or location.
- A berthing offer may be declined three times (maximum). After three declines and/or no response, applicants may be dropped to the bottom of the Wait List.
- Offers on hold (with Manager's approval): Applicant requesting hold offers are not pro-rated. It is the responsibility of the applicant to request the reactivation/extension of hold offers. Slip offers after the applications expired hold date WILL count towards the account.
- Applicants are required to show a copy of current vessel registration or documentation along with evidence of acceptable insurance. All insurance will be reviewed for compliance by Exigis LLC. Applicant's vessel will also be inspected by the Assistant Harbormaster and/or staff to

assure **seaworthiness (in working condition) and proper fit** of assigned berth. Applicant may be denied if the applicant fails to meet seaworthiness, beam, LOA, and other criteria(s).

- Only one person named Berth holder per application, not LLC's, Trusts, etc...
- Please email your application to sbh-waitlist@sfgov.com. Waitlist application(s) are not completed without payment.
- A current list is printed each month and placed in a binder at the front desk. You may call or come into the office to see your current wait status or view that list online under the Port of San Francisco, Maritime Division, South Beach Harbor.
- Side-ties accommodate vessel less than 20 feet. In general, there is no wait period for a side-tie, however, we have limited availability for small vessels WITH masts. Side-tie applicants DO NOT have the ability to transfer to larger slips.
- Slips/berths/vessels are restricted to the Rules and Regulations. Slip "fit" are strictly enforced. LOA length as advertised with 1' (one foot) overhang. Beam width as advertised minus 2' (two foot).

CCSF Office of the Assessor-Recorder - Notice for Vessel Owners and Marina berth holder:

There are two marine tax bills. One bill is for the Vessel Owners which can be identified by the account number on the tax bill. The other bill is for the Berth/Slip, that is, if you are a berth holder at the marina on government owned land. It can be identified by the block and lot number on the tax bill.
