


# **Advertising for Construction Bids**

### Crane Cove Park Playgrounds and Dog Park

- Scope of work construct two play areas and a dog park at Crane Cove Park
- Bids opened 8/21
- Construction expected December 2024 through September 2025
- Park remains open during construction, just the areas of work will be closed off.
- DBE goal of 22.2%








# **Advertising for Construction Bids**

### Amador Street Infrastructure Improvements

- Scope of work is full roadway reconstruction, water and sewer main replacement, pump station construction, street trees and landscaping.
- Bids due tomorrow (8/29/24)
- Construction expected December 2024
  through August 2026
- Work will be phased to maintain access for tenants and always allow a lane of traffic in each direction.
- DBE goal 22.2%








# **Other Upcoming Projects**

### **Pier 96 Crane Demolition**

- Bid documents in progress, expected to advertise for construction in Q1 2025 and start construction in Q3 2025.
- Public access not affected.
- LBE goal to be set Q1 2025

#### Pier 96 Gatehouse Demolition -

- Working on contract, expected to start construction in Q4 and be completion in Q1 2025.
- Public access not affected.









# **Other Upcoming Projects**

#### **Pier 90 Grain Silo Demolition Project**

- Scope is now to demo small buildings onsite, steel loading towers/bridges, and wharf.
- Design underway, construction start expected Q3 2025.
- Public access not affected.


#### Pier 96 Admin Building Improvements

- Design complete October 2024, construction expected in 2025.
- Will coordinate with the tenant during construction

#### **Pier 96 Offshore Wind Site Preparation**

• Promoting the project at the state and federal levels, and with interested industry stakeholders. No upcoming work scheduled at this time.









## **Portwide Wayfinding System**

- Eight pilot installations in place
- Portwide expansion in progress, adding 23 "pylon" and 11 "flag" signs
- Current design under revision by consultant
- Currently out to bid for manufacture through Office of Contract Administration (OCA)
- Timeline TBD, pending redesign, contracting results and map production. Projected mid- to late 2025 completion

## **Interpretive Pylon Refresh**

- **Overview:** Refresh graphic layout and interpretive content for 17 pylons (12 existing, 5 new) with design consultant.
- Existing/ Proposed Locations\*: Piers 45, 43, 35, 29, 9, 14, 30, 40, 48; Ferry Building; Rincon Park; Pier 52 Boat Launch; Agua Vista Park; 24<sup>th</sup> St. Plaza; Bayview Gateway; Islais Creek; Heron's Head Park.
- **Proposed Themes:** Waterfront history & key figures, Ramaytush Ohlone culture, Waterfront Resilience Program, Sea Level Rise & Resiliency efforts, and more.
- **Timeline:** Installation estimated late 2024/early 2025 (pending redesign + fabrication).
