**CMD Award Recommendation** 

The Contract Monitoring Division ("CMD") reviewed the three bids submitted for the above-referenced project and determined responsiveness to Chapter 14B pre-award requirements. Below is a summary of CMD's review.

#### **LBE Bid Discount**

A 2% SBA LBE bid discount was applied to NTK Construction, Inc.'s bid.

The three bids are presented from lowest to highest as follows:
