1. Announcements and Introductions

2. Approval of September 16, 2020 Draft Meeting Notes

Both Katy Liddell and Jane Connors were happy with the NAC Meeting Notes from the September 16, 2020 meeting and no changes were recommended.

3. Waterfront Resilience Program

Presented by: Brad Benson, Port of San Francisco

Overview

The Waterfront Resilience Program was developed to reduce seismic and climate change risk along sections of the bay waterfront. The Port Commission will be asked to endorse the goals of the program in December 2020. Addressing equity is included in the goals of the program.

There were a range of alternatives to review:

- Developing Priorities
- Focus on discrete components of the waterfront
- Obtain entitlements
- Physical start of work 2024 (potential)

A key component of the Waterfront Resilience Program was the Port's completion of the Multi-Hazard Risk Assessment ("MHRA"). The MHRA assessed a range of hazards and sea level rise (2'-3') scenarios and conducted geotechnical investigations to better understand soil conditions. The investigation found several areas of localized geotechnical risk including lateral spreading and liquification due to young bay mud, engineered fill, and sands.

Areas of for focused management include:

- South of the Bay Bridge
- Ferry Building (seismic risk)

- Bulkhead Wharfs North of the Ferry Building
- Embarcadero roadway
- Fisherman's Wharf

General physical solutions, depending on location, include the below construct subsurface buttresses to constrain nearshore submerged landslides:

- Drill and place large shafts
- Create "super" bulkhead wharf structures
- General bulkhead retrofits
- Mitigate liquification potential
- Other to be developed approaches

A comprehensive flood study (the federal government is estimated to pay for 65% of the cost) will be conducted to allow projects to be refined and to narrow construction alternatives. Some of the alternatives may require congressional funding.

Creeks and adjacent areas can be protected by non-structural measures, ecological enhancements, and adaptation zones among other approaches.

Completing risk reduction measures will require integrated seismic/flood measures, interagency cooperation, and careful consideration of construction components to contain localized disruption.

Questions/Comments

- 1) When will heavy construction take place [as currently estimated]?
 - a) The target commencement year is 2024, but work will start on smaller less impactful projects sooner.
- 2) Two comments regarding the 3rd Street Bridge (Lefty O'Doul Bridge):
 - a) The bridge is affected by high tides. How will sea level rise be addressed?
 - i) DPW just made a big investment in the bridge but did not include sea level rise projects. Further solutions to be developed.
 - b) The bridge is between the ballpark and Mission Bay construction. Are the developers having any issues?
 - i) The Giants have been engaged and are doing strong work in the Mission Bay site. They have been looking for cooperative arrangements and have been a good partner to address city projects.
