TEMPORARY CERTIFICATE OF OCCUPANCY (TCO) APPLICATION

Section 109A of the Port of San Francisco Building Code requires all buildings to have a Certificate of Occupancy. No building or structure shall be used or occupied and no change in the existing occupancy classification (change of use) of the building shall be made without the issuance of a Certificate of Final Completion and Occupancy.

Certain projects may apply for a TCO. TCO approvals are be based on written authorization of regulatory agencies such as SFFD (Port Fire Marshall), DPH, SFPUC, MOD, etc.; the completion of all life safety items, access provisions for the physically disabled, the number of outstanding items for final completion, the status of inspections, and the expected date for work to be completed.

When applicable, copies of SFFD, DPH, SFPUC, MOD, etc. written TCO approvals, in lieu of Final Approvals, <u>must be attached</u>. Please complete the information below, and submit to the Building Permits Desk at Pier 1, M-F 8:30-11:30am:
