1. <u>Welcome</u>

• Self-introductions by all present.

- 2. <u>Maritime Update (Joe Monroe)</u> <u>Cruise:</u>
- We finished up the fiscal year with just under 366k passengers. This is the 2nd highest passenger count on record. We were approximately 25k passengers under the record which was achieved last year.
- Planning is underway for the 10-year anniversary celebration of the James R. Herman Cruise Terminal. The event will be held on September 13th at the cruise terminal followed by a celebration event which will be open to the public. <u>Cargo:</u>
- We finished up the fiscal year with moving approximately 30k units through the facility, slightly ahead of last year. The minor increase is a result of import cargo or spot vessels received throughout the year.
- The CARB-at-berth regulation is set to go into effect on January 1, 2025.
- We continue to engage CARB to seek a low-activity terminal exception.
- We are awaiting CEQA findings to advance to final negotiations with Martin Marietta at Pier 92 for sand operations.
 - Ferry:
- The Port held a ribbon cutting ceremony on July 12th for Sea-Change, the world's first commercial hydrogen-fueled ferry.
 - Commercial Fishing:
- The Port Commission approved two items to provide financial relief to the commercial fishing industry in San Francisco's Fisherman's Wharf.
 - Salmon Boat and Crab Gear: Five-month rent relief for berth fees and gear storage rent for eligible fishers.
 - Salmon and Crab Processors: Five-month 50% reduction of lease rent for eligible tenants at Fisherman's Wharf.

Miscellaneous:

- We continue to work with regulators to advance our dredge work during the current dredge season. We are working to refine our internal process.
- Dredging priority locations this year are Pier 35, SBH and FW
- Sail GP event took place on July 13-14, 2024, in San Francisco with Spain taking the victory. Pier 80 was the site for the team bases and technical site details.
- The Portola Music Festival will take place on September 28 29, 2024 at Pier 80. This event is sold out.
- This year's 4th of July event was one of the safest and most vibrant events. This was made possible by the collaboration of city-wide departments. (Port Security, Maritime, and Port's maintenance division, SFPD, SFMTA, and others).
- Unaudited reports show our tenants saw similar sales numbers to 2017, surpassing 2019 sales.
- The Port celebrated the arrival of a nine-foot sculpture called As Sounds Turns to Noise created by Thomas J. Price. It depicts a young black woman dressed in jogging clothes and is located outside of Pier 1.
- 3. EPA Lithium Battery Fire Prevention/Management Exercise (Stephen Graves)

- The focus on the exercise was to try to level the playing field on the (new) hazard to the fire department and public safety and how to manage lithium battery fires.
- Pier 80 was chosen as the site to hold the exercise due to the number of vehicles shipped overseas that operate with lithium batteries.
- Tesla, Pasha, and EPA took part in this training.
