> SCA Environmental and (3) CDIM Engineering for As-needed Environmental and Planning Services, each contract in an amount not to exceed \$2,500,000

and to create a pre-qualified pool.

DIRECTOR'S RECOMMENDATION: Approve Attached Resolution No. 23-12

EXECUTIVE SUMMARY

Pursuant to Port Commission authorization (Resolution 22-44), Port staff issued a Request for Qualifications for As-Needed Environmental and related Professional Services. Five proposals were submitted by firms in response to the RFQ. One firm was found nonresponsive for failing to meet Minimum Qualifications. Four firms were responsive and met the eligibility requirements of the Contract Monitoring Division ("CMD") for the Local Business Enterprise ("LBE") Ordinance. A selection panel evaluated and scored the written proposals and held oral interviews. CMD monitored the selection process.

Port staff now seeks Port Commission authorization to award contracts for As-Needed Environmental and Planning Services to the three highest-scoring firms: (1) AEW Engineering (2) SCA Environmental and 3) CDIM Engineering. Staff recommends the award of each contract in the not-to-exceed amount of \$2,500,000, with a maximum term of five years (four years with the option to extend one extra year at the Port's discretion).

In addition to awarding three as-needed contracts, Port staff seek Port Commission authorization to create a ranked prequalified pool, consisting of all qualified firms, that can be used for a period of two years. Contracts issued to contractors in this pool will have a duration of no longer than two years. Port staff will follow solicitation requirements for award of additional contracts to firms in the pre-qualified pool, including seeking Port Commission approval for contracts from the pool with a value greater than \$200,000.

STRATEGIC PLAN OBJECTIVE

The contract opportunity will support the goals of the Port's Strategic Plan as follows: Sustainability:

By enabling access to a broad range of environmental expertise, the proposed contracts will support Port's goal to advance environmental stewardship to limit climate change and protect the Bay.

Equity:

By increasing the proportion of funds spent by the Port with local businesses competing for Port contracts by engaging teams that support the diversity of the City; and by requesting a copy of the proposing firm's Diversity, Equity and Inclusion plan.

Productivity:

By enabling implementation of \$27.5 million of funded capital projects and other projects that will maintain cargo volume and expand maritime terminal capacity, ensuring compliance with environmental approvals of the Pier 70 and Mission Rock development projects, and managing the waterfront and advancing environmentally and financially sustainable maritime, recreational, and economic opportunities to serve the City, the Bay Area region, and California.

BACKGROUND

In Fiscal Year 2019-2020, the Port entered into three (3) agreements for as-needed environmental and related professional services pursuant to Port Commission approvals. The three as-needed agreements included a maximum dollar value of \$2,000,000 each. All three agreements had an initial term of four years. The three prime contractors under the three contracts are1) SCA Environmental; 2) ESA-CDIM Joint Venture; and 3) AEW Engineering. Each of the teams also include a number of subconsultants in a variety of professional disciplines.

The LBE subconsulting requirement for the 2019 contract series is 12%. All current contracts are exceeding the 12% LBE subconsulting requirement, as shown in Table 1 below.

The exact scope of work for consultant assistance during the next four to five years is not fully known, but staff anticipates the needs for support in the below categories of work.

CONTRACT ADVERTISEMENT AND OUTREACH

On October 5, 2022, the Port published the RFQ for As Needed Environmental and Planning Services, Event ID 0000007501. The outreach list for this opportunity included 193 contacts with potential respondents, subconsultants, chambers of commerce and other professional organizations. The Port held a pre-submittal conference on October 12, 2022 over ZOOM with over 50 participants. The Port responded to 13 questions.

SELECTION PROCESS

Submittals were due on November 15, 2022 and the Port received five responses to the RFQ in advance of the submittal deadline. The following seven consultant teams responded to the RFQ:

- 1. AEW Engineering (Micro LBE-MBE)
- 2. SCA Environmental (Micro LBE-WBE)
- 3. CDIM Engineering (Micro LBE-OBE)
- 4. Hazen and Sawyer (Non-LBE) and Avila & Associates Consulting Engineers (Small LBE-WBE)
- 5. Albion Partners (Micro LBE-OBE)

Albion Partners was deemed non-responsive for not meeting minimum qualifications. Four proposals were deemed responsive to the requirements of both Chapter 6 and the Chapter 14B.

Selection Panel

The Port convened a four-member evaluation panel. The panel met on December 5 for orientation, on December 21 to confer and submit scores for the written proposals, and on January 11 for oral interviews. The four members of the panel have education and professional experience with environmental management and all panel members had experience with public sector public works projects. Two individuals are from the Port, one is from San Francisco Public Works, and one is from the San Francisco Public Utilities Commission. The Port's CMD Compliance Officer approved the panel composition and attended all selection panel meetings.

Evaluation Criteria

The selection panel evaluated and scored the written proposals based upon the following criteria:

35 points — Proposer Experience and Qualifications

1 point — Submittal of a Diversity Equity and Inclusion Plan

25 points — Sub-Consultant Firm Qualifications

24 points – Team Personnel Experience and Availability Table
 15 points – Breadth of Services Provided by Proposing Team

100 points Total

The RFQ required a respondent to score 75 points or more on the written proposal to be invited to attend the oral interview and qualify for the prequalified pool.

On January 11, 2023, the evaluation panel conducted oral interviews, evaluated and scored each candidate firm based on a presentation and three questions. Three of the questions were provided 48-hours prior to the interview and one interview question was asked in the interview.

The City Administrative Code Chapter 14B, the LBE and Non-Discrimination in Contracting Ordinance, establishes rating bonuses for LBE firms and LBE joint venture partnerships.

The complete rankings for firms advanced for the oral interview are shown in Table 2.

SELECTED CONSULTANTS FOR CONTRACTS

Based on total scores, Port staff recommends awarding the As-Needed Engineering contracts to the top three ranking proposals. Each firm has proposed a team that meets or exceeds the 15% LBE requirement of the contracts.

AEW Engineering

AEW Engineering, Inc. (AEW) is a San Francisco-based Micro Local Business Enterprise/Minority Business Enterprise (micro LBE/MBE). AEW has been in business for over 20 years providing environmental consulting services on over 850 projects in the city of San Francisco and the Bay Area. The team intends to exceed the LBE requirement with a 16% commitment to six LBE subcontractors (LBEs). This team also includes nine non-LBEs.

SCA Environmental, Inc.

SCA Environmental, Inc. (SCA) is a San Francisco-based Micro Local Business Enterprise/Woman Business Enterprise (micro LBE-WBE). SCA was formed in 1992 and is a multi-disciplinary environmental consulting firm offering services in the fields of hazardous materials management, geo-environmental investigation and remediation, industrial hygiene services, asbestos and lead management, and environmental engineering. SCA's Principals and Senior Managers have designed, implemented and managed over 10,000 projects in the San Francisco Bay Area. The team intends to meet the 15% LBE subconsulting requirement with 12 LBEs. There are also 16 non-LBEs.

CDIM Engineering, Inc.

CDIM Engineering, Inc (CDIM) is a San Francisco-based Micro Local Business Enterprise/Other Business Enterprise (micro LBE-OBE). CDIM was formed in 2016 and has grown with the Port. CDIM first performed services as an LBE subconsultant, then as a Joint Venture Partner, and has now won award as a solo Prime consultant. The team intends to exceed the LBE subconsulting requirement with a 24% participation commitment to 12 LBEs. There are also 12 non-LBEs.

SELECTED CONSULTANTS FOR PREQUALIFIED POOL

The RFQ specified that all responsive firms that score seventy-five points or more will be entered in the prequalified pools. The three firms that have been selected for contract award will be entered into the prequalified pool and the one additional team includes:

Hazen and Sawyer and Avila & Associates JV

Hazen and Sawyer (non-LBE) has been in business for over 72 years and is a nationally recognized full-service environmental and engineering firm focused solely on water projects. Avila & Associates (Small LBE-WBE) has over 20 years of experience offering a multi-disciplined team of 26 civil engineers, environmental scientists, GIS specialists, and construction managers.

FUNDING

Funding for these proposed contract services will be allocated on an annual basis through the Port's programmatic project budget.

WHEREAS,	In 2019, the Port issued a Request for Qualifications ("RFQ") for "As- Needed Environmental and Planning Services" to select consultants to provide comprehensive to support the Port in its facilities development, leasing and maintenance, parks and open spaces, and habitat protection; and
WHEREAS,	The Port's current set of as-needed Environmental and Planning Services contracts executed pursuant to the RFQ have provided a timely and cost-effective vehicle for provision of professional services; and
WHEREAS,	At its meeting on September 13, 2022 through Resolution 22-44, the Port Commission authorized staff to issue a RFQ to solicit and select up to three entities to provide as-needed environmental and planning services each contract with a not-to-exceed value of two and a half million dollars (\$2,500,000) for a total combined not-to-exceed value total of seven and a half dollars (\$7,500,000); and
WHEREAS,	Resolution 22-44 authorized staff to create a pre-qualified pool of qualified respondents for future solicitations and contract award; and
WHEREAS,	The Port Director has authority under Chapter 6 to award contacts at or below the minimum competitive amount, currently \$200,000;
WHEREAS,	Port staff advertised the RFQ on October 5, 2022 and received five proposals on November 15, 2022; and
WHEREAS,	Port staff convened an evaluation panel to evaluate and score the proposals and hold oral interviews; and
WHEREAS,	Port staff selected the three highest responsive scored proposals for contract award; and
WHEREAS,	Port staff selected all four qualified proposals for placement on the pre-qualified list; and
RESOLVED,	That the Port Commission authorizes Port staff to award and negotiate up to three professional services contracts per Event ID: 0000007501, As-Needed Environmental and Planning Services, for the services described in the accompanying staff report and RFQ to (1) AEW Engineering (2) CDIM Engineering, Inc 3) SCA Environmental, each in an amount not to exceed \$2,500,000, each

with a contract term of four years and option to extend the term for one additional year, and with a total combined amount for immediate contract awards not to exceed \$7.500,000; and

RESOLVED,

That the Port Commission authorizes Port to create a prequalified pool from Event ID 0000007501 As-Needed Environmental and Planning Services for the following qualified firms in the below ranking (1) AEW Engineering, (2) CDIM Engineering (3) SCA Environmental, and (4) Hazen and Sawyer and Avila & Associates Joint Venture; and

RESOLVED

That the Port Commission authorizes Port staff to advertise additional contracts from the pre-qualified pool. Additional contracts from the prequalified pool that are at or below the minimum competitive amount stated in Chapter 6, currently at \$200,000 shall be awarded by the Port Director. Contracts above the minimum competitive amount shall be awarded by the Port Commission.

The SF Port has confirmed that AEW Engineering, SCA Environmental, and CDIM Engineering are eligible for award and all four proposers including, Hazen/Avila JV, will be placed in a pre-qualified pool.
