



### **Community Relations**

All of our food & beverage vendors on-site will be locally owned & operated

Expanding on the same standard of neighborhood cleaning demonstrated during our Midway block parties, ensuring residential/commercial satisfaction post-event

Door to door flyering via existing neighborhood contacts

A portion of all proceeds will be donated to the charitable foundation, Lyric Center for LGBTQQ+ Youth So-SF adjacent shows

Seven shows across three venues

Harm reduction efforts will be spearheaded by our medical partner at Mutual Aid Response Services





### Site Improvements

Adding ten(10) HD indoor/outdoor cameras that the Terminal Operator will have permanent access to

Repairing the Northern rollup doors ahead of the event

Continue with safety and patron right of way improvements throughout the site.

Clean, repair and mediate roof, gutter and drainage systems



### Sound Management

- The majority of previous complaints were derived from outdoor noise and a much larger scale production. Indoor only entertainment will greatly reduce residential impact
- Midway produces over 12 outdoor block parties per year with large sound systems and receives minimal to no sound complaints.
- Deploying a dedicated roaming dB reader for San Francisco region
- Purchasing & deploying sound treatment for Shed A to further reduce potential impacts

#### **Sound Management**

 Only deploying indoor sound will drastically cut down on the sound complaints experienced historically. Engaging a dB meter locally who can respond to complaints in real time to communicate necessary adjustments.

#### **Community**

 Engaging with our immediate residential neighbors in order to minimize disruptions to their standard business practices, while ensuring the optimal event experience.

#### **Traffic**

Working w/ various local agencies & vendors to determine the best possible plan for closures
providing ample guest security but minimal commercial disruption.
