



## Plumbing Permits & Inspections

*Effective January 01, 2021, Port of San Francisco and SF Department of Building Inspection – Plumbing Inspection Division will require Port applicants to obtain a plumbing permit and inspection from SFDBI or types of work defined in the following table. SFDBI performs this inspection work in support of the Port of San Francisco Building Permit process.*

Here are the steps and requirements (subject to modifications):

### 1. Review the various plumbing labor that require a plumbing permit and inspection from SFDBI

#### A. Plumbing Scopes Only:

1. Submit a [Port building permit application](#) and plans to Port for code compliance review; obtain Port permit application number and FIN (Facility Identification Number)
2. Await for Port plan review completion and confirmation that Port permit application is ready to be approved
3. [Apply for a plumbing permit online with SF DBI Plumbing Inspection Division \(PID\)](#) and reference Port application number and FIN within the scope description  
\*Note: Use the following Port jurisdiction general address: 1 Port
4. Upon PID plumbing permit issuance, provide Port with PID permit number as needed for Port permit issuance
5. Upon Port permit issuance and plan approval – work may commence
6. [Rough and final plumbing inspection appointments shall be made with PID online](#)

#### B. Alterations/ Tenant Improvements (with plumbing scopes):

1. Follow steps as listed above
2. In addition to PID inspections, applicant/ contractor is responsible for requesting Port and SFFD inspections where required

### 2. Port Inspector/ Staff to verify inspection completion on PID website and obtain a record copy for Records Retention Policy

#### Fees:

- Applicants are responsible for paying the required fees from each City Agency
- Plumbing permit & inspection fees are due at the time of submittal to PID (online payments accepted)  
\*\*Note: General contractors with a B license trying to obtain a plumbing permit from PID will need to contact SFDBI directly. SFDBI staff will have to provide an invoice to the general contractor. PID system will not allow a general contractor to obtain plumbing permit online
- Plumbing plan review fees are due at the time of submittal to Port (online payments not accepted. Contact Port permit desk for more information)
