The Port of San Francisco (the "Port"), a department of the City and County of San Francisco (the "City") invites proposals for a Construction Manager/General Contractor ("CM/GC") contract referred to as <u>MISSION BAY FERRY LANDING RFP/RFQ, Contract #2819</u> (the "Project"). The Port intends to award the CM/GC contract under Best Value criteria. The Project includes construction of a single-float, two-berth landing which consists of a pier, connecting ramp, gangway, and a covered translucent canopy located at the intersection of 16th Street and Terry Francois Blvd. Other components of the Project include dredging approximately 109,200 cubic yards of material, installation of a sediment cap as well as construction to the surrounding plaza and upgrades to Agua Vista Park.

California law requires that construction workers employed on City funded projects be paid not less than the prevailing wage rate.

#### TO ENSURE LABOR STANDARDS COMPLIANCE, THE OLSE

- Visits jobsites and interviews workers regarding rates of pay and types of work performed
- Investigates complaints to verify that workers receive prevailing wages including fringe benefits, travel and subsistence, holiday, overtime, and other required payments
- Conducts audits by reviewing certified payroll records, fringe benefit statements, inspector's logs, sign-in sheets, and pay check stubs to verify payment of prevailing wage and proper classification of work
- Assesses penalties for non-submission of records or non-payment of prevailing wage

## **City Labor Ordinances**

#### San Francisco Labor Laws for City Contractors

#### Effective February 1, 2019

#### Minimum Compensation Ordinance (MCO) – 12P

#### Wages and Paid Time Off (PTO)

For a company that has 5 employees or greater, anywhere in the world. Includes subcontractors.

- Any employee who works on a City contract for services:
- For-profit rate is \$17.00/hour as of 11/11/18
- Non-profit rate at least SF Minimum Wage (\$15.00/hour) as of 7/1/18; Effective 7/1/19 \$16.50/hour
- Public Entities rate effective 2/1/19 \$16.00/hour; Effective 7/1/19 \$16.50/hour
- 0.04615 hours of Paid Time Off (PTO) per hour worked (can be used as vacation or sick leave, and is vested and cashed out at termination)
- 0.0392 hours of Unpaid Time Off per hour worked allowed without consequence
- Employee must sign a "Know Your Rights" form
- Posting Requirement

#### Health Care Accountability Ordinance (HCAO) - 12Q

For a company that has > 20 workers (for profit)/ > 50 workers (nonprofit), anywhere in the world – Includes subcontractors

Any employee who works at least 20 hours a week on a City contract for services:

Either:

- A) Offer a compliant health plan with no premium charge to the employee. See Minimum Standards OR
- B) Pay \$5.15\*\* per hour to SF General Hospital (not Healthy San Francisco and not a benefit to employees) OR
- C) Pay \$5.15\*\* per hour to covered employee. N/A to SFO and San Bruno Jail locations. Employee must live outside of SF and work on a City contract outside of SF. See HCAO for more details.
- Employee must sign a "Know Your Rights" form
- Posting Requirement

#### Health Care Security Ordinance (HCSO)

Any employee who works an average of 8 hours a week in the City of San Francisco (whether or not on a City contract) and is not covered by the HCAO:

- Effective 1/1/19 Spend \$1.95 or \$2.93 (depending on your size) per hour on their health care (e.g. health insurance, or a contribution to Healthy San Francisco)
- Employee can only waive their rights:
  - By signing an official HCSO voluntary waiver, and
  - o If they show they have insurance through another employer

#### Fair Chance Ordinance (FCO) - 12T

#### **Hiring Process**

- You may not ask about criminal background in a job application or at the start of the hiring process

## **Crediting Rules:** Trucking & Equipment Rental

## Trucking:

- List all lower tier trucking subs on CMD Form 6A.
- 100% credit when an LBE-owned trailer is pulled by an LBE-owned cab and the driver of the cab is an employee/owner of the LBE firm.
- Only 60% participation credit when an LBE owned trailer is pulled by a non-LBE owned cab. And vice versa.
- Disposal and dump fees do not count towards meeting the LBE subcontracting requirement.

### LBE Equipment Rental Firms:

- 60% of the equipment rental fee (current market rate) will be given for equipment owned by the LBE and certified by CMD.
- Construction equipment such as storage tanks, grit separators, debris boxes etc. utilized in conjunction with trucking and hauling operation are not considered under the "Trucking and Hauling" category. Crediting rules for equipment rental will apply.

## Crediting Rules: LBE Manufacturers/Suppliers/Subcontractor (Non-Specially Manufactured Items)

- If a TP bidder obtains materials, supplies, articles or equipment from:
  - LBE Manufacturers: 100% of the cost of the item regardless of who installs the item.
  - LBE Suppliers:
    - 60% of the cost of the item if the supplier performs a Commercially Useful Function by taking possession of the items and assuming the risk of their delivery.
    - Only 5% if the supplier does not take possession and assume the risk of delivery (i.e. broker or agent).

### LBE Construction Subcontractors:

100% of the cost of the item and labor

## Crediting Rules: Specially Manufactured Items (SMI)

- If the TP bid documents identify one or more SMI, CMD will calculate LBE participation according to the following rules:
  - If manufactured by and purchased from a <u>CMD-certified LBE</u> <u>manufacturer</u>, 100% of the purchase order amount will be credited
  - If purchased from a <u>CMD-certified supplier</u>, only 5% of the purchase price of the item will be credited
  - If supplied and installed by a <u>CMD-certified LBE construction</u> <u>subcontractor</u> then 5% of the SMI purchase price of the item and 100% of the installation labor cost will be credited
  - A bidder may receive 100% for any labor associated with the installation of a SMI provided the installation is performed by a <u>CMD-certified construction subcontractor</u> in accordance with normal industry practices.




