CURRENT SOUTH BEACH HARBOR WAIT LIST POLICIES:

- An annual <u>non-refundable</u> fee of \$100- No deposit required. Wait applicants are expected to make prompt annual fee
 payments noting their account number. Keep your receipt when making a debit or credit payment. No cash accepted.
- Payment should be made every year no later than 15th of respective Due Month.
- 10% Late Fees will apply, if we don't receive the Payment on time.
- Nonpayment of fees for 4 months after the Due month will result in Removal from Waitlist.
- Wait applicants must update: Phone numbers, Email and mailing address if changes.
- Berth holders can pay \$75 a year to get on an internal move list to change the berth size and/or location.
- A berthing offer may be declined three times (maximum). After three declines applicants may either be removed, or one time dropped to the bottom of the Wait List. Removal from list will result in the forfeiture of all paid fees.
- If one offer is declined, maximum wait for next offer is not more than 6 months.
- Applicants are required to show a copy of current vessel registration or documentation along with evidence of acceptable insurance to assume tenancy. All insurance will be processed by Exigis LLC. Applicant's vessel will also be inspected by the Assistant Harbormaster and his staff to assure seaworthiness and proper fit of assigned berth. Tenancy may be denied by if applicant fails to meet the beam, LOA, and other criteria.
- No live boards allowed. Only one person named Berth holder per application, not LLC's or Trusts.

- A current list is printed each month and placed in a binder at the front desk. You may call or come into the office to see your current wait status or view that list online under the Port of San Francisco, Maritime Division, South Beach Harbor.
- Side-ties accommodate vessel less that than 20 feet. In general, there is no wait period for a side-tie, however, we have limited availability for small vessels WITH masts. Side-tie tenants DO NOT have the ability to transfer to larger slips.
- Slips are restricted to the Rules and Regulations as of 2020. We allow only 12' in. overhang & -2' ft. advertised beam width.

Notice for Vessel Owners and Marina Tenants

There are two marine tax bills. One bill is for the Vessel Owners which can be identified by the account number on the tax bill. The other bill is for the Berth/Slip, that is, if you are a tenant at the marina on government owned land. It can be identified by the block and lot number on the tax bill.
