2. Maritime Update (Peter Dailey)

 The Port held the first free public event at James R. Herman Cruise Terminal at Pier 27 on Sunday, July 12, 2015. The San Francisco Symphony performed with approximately 6,000 people in attendance.

- The Port added Menzies Aviation, located at San Francisco International Airport, as the fifth user of Foreign Trade Zone #3. The Chevron Refinery located in Richmond is the initial user of the FTZ subzone, operating since 1998.
- Chevron is due to renew their FTZ subzone agreement, but this has been postponed due to contention between the ILWU and Chevron in Australia and New Zealand. Chevron is now operating under a 180-day extension on their current agreement, until the Port Commission approves a new agreement.

- MCAC will review this issue at its September 17 meeting and will consider submitting a letter of support for the Chevron FTZ subzone agreement.
- Catharine Hooper reported Fleet Week and the Blue Angels will be back in San Francisco in October 2015. The first ship arrives on Monday, October 5. Three U.S. Navy ships, a U.S. Coast Guard cutter, and a Canadian frigate will arrive on October 7. The Parade of Ships will take place on October 9, with the first ship passing under the Golden Gate Bridge at 11am. All ships will depart on Tuesday, October 13.

3. Update on SF Giants Seawall Lot 337 project (Fran Weld, Mission Rock/337 team)

- The Mission Rock project consists of transforming the parking lot south of AT&T Park (known as Lot A) into affordable housing, parks and open space, including the historic Anchor Brewing and more.
- The Mission Rock Initiative, supported by the SF Giants, will be on the November ballot.
- The design will accommodate truck access into and out of Pier 48/50.
