

As Needed HAZ MAT RFQ: Background

- Awarding up to four master agreements with a total not-to-exceed amount of \$1.2 Million
- Four year term with option to extend one additional year
- Two contracts valued \$1.5 Million awarded in 2016
 - Environmental Logistics
 - Eagle Environmental

Anticipated Services

- 1. Recover, assess, package, transport, treat and properly dispose of potentially hazardous waste, as well as abandoned, or otherwise derelict marine vessels.
- 2. Ship wastes to disposal facility no later than three days after the date waste is picked up from the Port.
- Pump out and recycle used oil, oily water, and oily sludge from various collection tanks.
- 4. Remove hazardous and oily wastes at regularly scheduled intervals (for example: once per month, or once every other month).
- 5. Perform over-the-water fuel and oil transfers following established and accepted safe industry standards and procedures.
- 6. Provide all services necessary to safely remove derelict marine vessels.
- 7. Provide lab-pack and/or bulking services using qualified and trained personnel
- 8. Administrative services
